- a. <u>Periscope Mirror</u>. On more in-depth discussions, it was agreed that the view from Apollo Green, with the hedgerow at the bottom, would be very challenging as the hedgerow is not owned or maintained by FCC. If the budget allows, an alternative option will be presented.
- b. <u>Reflection Bench</u>. This will surround the old tree on the corner of Apollo Green and all agreed this would be a good idea. Concern was raised about having metal seating, regarding heat and cleaning. However, David confirmed that it would be inspected by ROSPA for safety.
- c. <u>Polished Spere</u>. This will be situated on the corner of Apollo Green near the school. All agreed that this would be a nice idea.
